**Assumes the highest personal Federal marginal tax rate (50% for 1983 thru 1986; 38.5% for 1987; 28% for 1988 thru 1990; 31% for 1991 and 1992; 39.6% for 1993 thru 2000; 39.1% for 2001; 38.6% for 2002; and 35% for 2003 thru 2012, and 39.6% for 2013 thru 2016) and PA personal income tax rate (averaged 2.456%, from 1983-1997; 2.8% from 1998 thru 2003 and 3.07% from 2004 thru 2016.)
